TO AMEND ORDINANCE NUMBER 16, SERIES 2024-2025, WHICH WAS APPROVED ON FEBRUARY 14, 2025 TO AUTHORIZE THE MUNICIPAL ADMINISTRATION OF ARROYO AND ITS MAYOR, HON. ERIC BACHIER ROMAN, TO REALIZE THE NECESSARY EFFORTS AND TO SIGN ALL DOCUMENTATION TO APPLY FOR FUNDS THROUGH A PROPOSAL TO THE FEDERAL AGENCY RURAL DEVELOPMENT - USDA, UNDER IT'S COMMUNITY FACILITY PROGRAM FOR SERVICE TO THE COMMUNITY OF ARROYO.

WHEREAS: The Municipality of Arroyo and its mayor, authorized by Ordinance Number 16, Series 2024-2025, submitted a proposal to apply for funds issuing from the Rural Development - USDA from it's Community Facility Program to acquire equipment necessary for the servicing of Arroyo community.

WHEREAS: As of today, it is necessary to amend the Ordinance Number 16, Series 2024-2025, to modify the equipment to be acquired as indicated:

1. New Way Brand Trash Compactor Box Cobra model of 20 cubic yards of capacity, Hopper of 3.0 cubic yards of capacity and hydraulic closures, compaction bottles of 5 "diameter with a compaction force of 1,000 pounds / cubic yards (1 unit);
2. 20" long x 8" wide Tow Box, reinforced HD construction, smooth tola floor, ¼ double reinforced rear door with manual closing, cab protector, 4 flaps, PTO and pump system, Pac-Mam debris removal equipment (1 unit);
3. Hydraulic Excavator Caterpillar 320GC (1 unit);
4. Transit Passenger Wagon 15 passengers (4 units);
5. Camion Tumba 17-21 yardas (1 unit)
6. Dump Caja Volteo 8-10 yardas (1 unit)
7. SUV 4x4 2025 or 2026 (8 units)
8. Truck 2500 (10 units)
9. Truck 2500 Lifter Tommt Gate 1,300 lbs (1 unit)
10. Ram Pro Master [Anaqueles] (3 units)
11. Ram Pro Master 1500 Tradesman Cargo Van (1 unit)
12. Marverick 60" Kohler (2 units)
13. Trimmer ind loop handle (20 units)
14. Tire changer duty (1 unit)
15. Tire changer electric table top hybrid (1 unit)
16. Carreton (1 unit)
17. Crown steel concrete mixer (1 unit)

WHEREAS: The described projects in second whereas have an estimate cost of approximately \$2,214,712.66, which will be requested to the described federal agency, to provide services to the community of the Municipality of Arroyo.


THEREFORE: ORDERED THE FOLLOWING BY THE MUNICIPAL LEGISLATURE OF ARROYO, PUERTO RICO:

SECTION 01: Ratify the authorization to the Mayor of Municipality of Arroyo, Hon. Eric Bachier Roman to realize pertinent efforts in relation to the

application of necessary funds in accordance with norms, regulations and conditions established by the Federal agency, Rural Development - USDA on its Community Facility Program and to comply with all previously established requirements for the submission of the proposal.

- SECTION 02:** Amend the Ordinance Number 16, Series 2024-2025, to correct the equipment to be acquired and the estimated cost thereof as presented in this Ordinance.
- SECTION 03:** Ratify the authorization to the Mayor, Hon. Eric Bachier Roman and all the Directors of the Municipal Branch Offices or to concerned staff, to comply and to sign by and in name of the Municipality of Arroyo all the necessary documents for the submission of the Proposal to Rural Development - USDA and its Community Facility Program, and the application for such loans.
- SECTION 04:** This ordinance, because it is of urgent and necessary nature, will become in effect once approved by the Municipal Legislature, and signed by the Mayor.
- SECTION 05:** Copy of this ordinance will be sent to the Office of Management and Budget, to the Department of State of Puerto Rico, Department of Municipal Federal Programs, HUD and other pertinent agencies for their knowledge and action.
