FROM THE MUNICIPAL LEGISLATURE OF ARROYO, PUERTO RICO, AUTHORIZING THE MUNICIPALITY TO APPLY FOR AND OBTAIN FINANCIAL ASSISTANCE IN THE AMOUNT OF \$ 100,000.00 TO THE HOME IMPROVEMENT PROGRAM OF THE UNITED STATES DEPARTMENT OF AGRICULTURE, UNITED STATES ECONOMIC COMMUNITY 19 OFFICE, UNDERGROUND COMMUNITY, 19TH OFFICE OF UNARMED OFFICE -PART "N" OF THE FEDERAL HOUSING ACT OF 1949, AS AMENDED; FOR THE PURPOSE OF A DONATION OF HOMES RECONSTRUCTION FUNDS OF LOW-INCOME AND WELL-LOW-INCOME PERSONS; AND FOR OTHER PURPOSES.

WHERE AS : The Municipality of Arroyo, has planned to start a project to repair homes for people with low and very low income. The Law No. 107 of August 14, 2020 known as the Municipal Code of the Commonwealth of Puerto Rico. ", in its Article 1.008 q. stipulates that the Mayor on behalf of the Municipality may enter into agreements and contracts with the federal Government, agencies, departments, public corporations, instrumentalities of the Government of Puerto Rico and the municipalities, as well as for the development of municipal public works and facilities and for the provision of any public services, in accordance with applicable federal or state laws and to promote the viability of the work or project to be carried out and any delegation of powers.

WHERE AS : Law No. 107 of August 14, 2020 known as the Municipal Code of the Commonwealth of Puerto Rico, in its Article 1.008 s. stipulates that the Mayor on behalf of the Municipality may grant and donations or any other kind of aid in money or in services to non-profit entities constituted according to the laws of Puerto Rico, subject to whether they are for purposes and activities of public interest and prior compliance with the provisions of this Code.

WHERE AS : To obtain the necessary funds for the completion of the proposed project, the Municipality needs \$ 100,000.00 and cannot obtain the funds from other sources due to the current conditions of low municipal revenue collections from the sources of sales tax and municipal

taxes and licenses, and other conditions.

WHERE AS : The Municipality will submit a proposal to obtain the necessary funds to complete the housing preservation Grant in the United States Department of Agriculture, Rural and Economic Community Development Office, Part 1994, Sub-Part "N", of the 1949 Federal Housing Law, as amended.

THEREFORE : **HENCEFORTH BE RESOLVED BY THE MUNICIPALITY OF ARROYO LEGISLATURE:**

SECTION 1 : To authorize the Municipality to present a proposal to request funds for the preservation of very low-income persons residences.

SECTION 2 : To authorize Hon. Eric Bachier Román, Mayor, to accept the conditions established by the Housing Preservation Grant of the United States Department of Agriculture, Rural and Economic Community Development Office, Part 1994, Sub-Part "N", of the 1949 Federal Housing Law, as amended, that need to be completed before the financial assistance can be obtained.

SECTION 3 : To offer the services as stated by the program within its recourses to the residents of the service area without discrimination due to race, color, religion, national origin or political affiliation at a reasonable cost.

SECTION 4 : Law No. 107 of August 14, 2020, known as the Municipal Code of the Commonwealth of Puerto Rico.", In Article 1.008, stipulates that the Mayor on behalf of the Municipality may contract the professional, technical and advisory services that are necessary to carry out municipal activities, programs and operations or to fulfill any public purpose authorized by this Code or by any other law that may apply to municipalities.

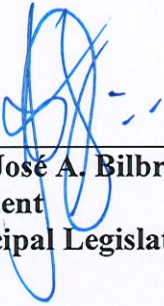
SECTION 5 : To authorize Hon. Hon. Eric Bachier Román, Mayor to comply with, sign for and on behalf of the Municipality all the necessary and required documents, forms as requested by the Housing Preservation Grant of the United States Department of Agriculture, Rural and Economic Community Development Office, Part 1994, Sub-Part "N", of the 1949 Federal Housing Law, as amended.

SECTION 6 : Once the proposal is approved, to authorize the implementation of the Housing Preservation Program for persons form extremely low income from the Municipality of Arroyo.

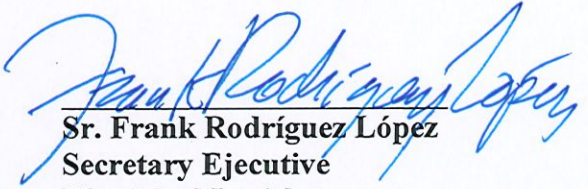

Municipal Affairs and to the state and municipal agencies that has jurisdiction for final action.

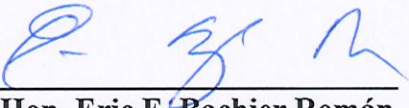
